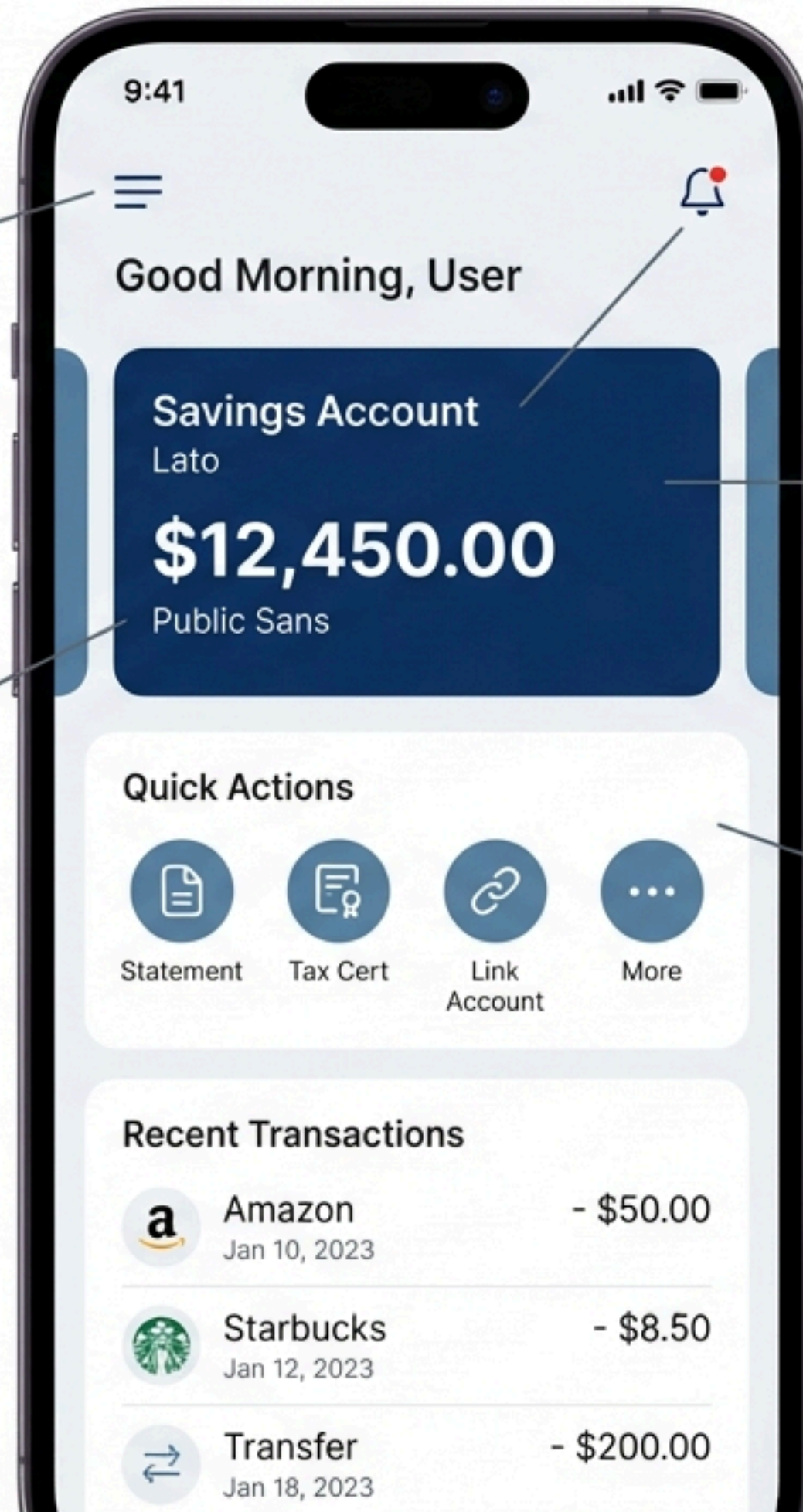
The Open Digital Banking Ecosystem
